## SCHOLARSHIP CRITERIA

- A) An immediate family member (*e.g. son, daughter, sister, brother.*), or anyone who has legal/permanent residence in the household of any WFC Jr. Foundation Board Member is ineligible to receive a WFC Jr. Foundation Scholarship Award.
- B) APPLICANT must be an African–American and/or other United States citizen.
- C) APPLICANT must be a high school senior, attending a 2 or 4 year college or university, or attending a technical school/trade school at the time the application is submitted.
- D) APPLICANT must have a minimum Cumulative Grade Point Average (C.G.P.A.) of 2.3 (*based on a 4.0 maximum scale*) or equivalent based on other officially stated maximum scale of Applicant's school system.
- E) APPLICANT must be accepted by an accredited college/university; technical/trade school and must provide proof of enrollment before actual allocation of the awarded funds.
- F) Total Family Income of APPLICANT must be **\$60,000** per year or less.
- G) Applicant must provide two (2) letters of recommendation.
- H) The application must be post marked by December 15, 2006
- I) **IN ORDER TO RECEIVE THE SCHOLARSHIP AWARD, RECIPIENT MUST AGREE TO ATTEND the Foundation's Annual Scholarship Luncheon and Celebration in *its entirety*.**
